By checking the boxes below you are agreeing to the rescue's foster conditions *

- ☐ The dog will live primarily indoors and is NOT to be left outside unsupervised, even in a fenced yard, for extended periods. If taken outside the home environment, the dog will not be allowed off-leash.
- ☐ I will help the dog recuperate through basic behavioral training including but not limited to potty training, nipping, jumping, humping, etc
- ☐ I understand that HH does not make any representation concerning the health, condition, training, behavior, or temperament of the dog. I will, therefore, take all due care to protect myself and others who may come in contact with the dog from bodily harm.
- ☐ HH will be responsible for any veterinary care charges incurred for the dog, but ONLY if HH has authorized such care. Foster Parent must contact Jessica Liu immediately if the rescued dog should encounter such a medical emergency at 626-377-2869. (All treatment MUST be pre-approved).
- ☐ I understand that in the event that I am unable or unwilling to care for the foster dog within the agreed upon three (3) month period, there is often no back-up foster. Therefore, I agree to give HH time to find a suitable alternative, and during this time I will do my best to continue caring for the dog and help HH find an alternative foster.
- ☐ In NO EVENT will I place the dog in a shelter, abandon the dog, allow the dog to let loose in the streets, or euthanize the dog.
- ☐ I agree to notify HH at least five (5) weeks in advance of any travel plans, and I will be responsible for arranging for the safe care of all foster dog(s) and pay all related boarding expenses if HH is unable to locate suitable accommodations for the foster dog(s).
- ☐ I understand that my foster dog may have an undiagnosed illness that could be transmitted to other pets or persons in my household. I agree to keep my own pet(s) up to date on vaccines and dewormers.
- ☐ I understand that rescue dogs may be frightened or exhibit unusual behavior when first placed in a new home. I agree to give the dog a fair chance to decompress and adjust to its new foster home. I agree to notify HH of any biting or display of aggression.
- ☐ I agree that any foster dog is owned solely by and is the property of HH and that I will not remove any dog entrusted to me from my primary residence or dispose of any dog in any manner without the prior approval of HH.
- ☐ I will return the dog to HH immediately upon request.
- ☐ I agree to an inspection of my property, upon request, by a representative from HH.
- ☐ I agree that I will exercise extra caution if my foster dog encounters any dogs that are unaltered. If my foster dog is unaltered, I will refrain from allowing close contact.
- ☐ I agree that I WILL NOT at any time take the foster dog to any dog park with other canines around.
- ☐ I agree to notify HH immediately of any suspected illness, medical issues, runaways, or death of a foster dog under my care.
- ☐ I will review the mandatory videos before taking possession of the dog (link at bottom of application).

Release of Liability and Indemnification:

- ☐ I understand that live animals are unpredictable and that animal bites or other injuries to humans and other animals or damages to property may occur. I acknowledge that while any foster dog(s) remain the property of HH, I assume full responsibility for any damages to property or injuries to other persons or pets caused by the foster dog(s) and I hereby release HH and its officers, directors, agents, and volunteers (the "Indemnitees") from any claims of liability for the conduct of the foster dog(s). I agree to indemnify, defend and hold harmless the Indemnitees from any and all claims of liability, damages, costs, expenses, and causes of action arising out of this agreement, including in consequence of any injury, damage or harm caused by the foster dog(s), except in cases where such injury, damage, or harm is the result of HH's gross negligence or willful misconduct.
- ☐ Foster Parent agrees to pay HH any and all expenses, including court costs and reasonable attorney fees, in enforcing the terms and provisions of this agreement.

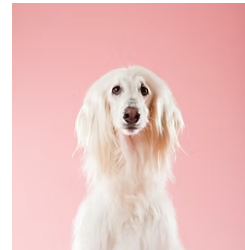
